## PROFESSIONAL WETLAND CERTIFICATION PROGRAMS UPDATE

The 1994 goals for the VAWP include examining the current need for professional certification of wetland delineators and exploring various options for developing and implementing such a program within the Commonwealth of Virginia. The VAWP has formed a Wetland Delineator Certification Committee. The appointees are Nancy Barker, Gary Cooke, R. Harold Jones, Jack Kane, Lee Mallonee, Jim Perry, and Steven Russell. The committee met during the fourth week of June to begin discussions on these issues, formulate strategies, allocate responsi-

bilities for tasks, and provide recommendations to the Board.

The Society of Wetland Scientists (SWS) has officially implemented their certification program. The society, an international organization, will provide certifications for Professional Wetlands Scientists (PWS) and Wetland Professional in Training (WPIT) to qualified applicants. As of June 5, 1994, approximately 40 individuals have received PWS certifications and two individuals have received verification that they qualify for WPIT status. As with other professional societies

which have initiated certification programs, SWS has approved a grandfathering clause allowing much initial latitude in educational requirements, but not in experience requirements. This grandfathering period will apply to applicants through June 1, 1995. For an application package you may contact the SWS Business Office, P. O. The Army Corps of Engineers completed three demonstration projects for the Wetland Delineator Certification Program (WDCP) in March, 1994. The

demonstration projects, which began in March 1993, took place in the states of Washington, Maryland, and Florida and were administered by the Seattle, Baltimore, and Jacksonville districts, respectively. The intent of the WDCP is: (1) to improve the quality and consistency of wetland delineations submitted to the Corps and (2) to streamline the regulatory process by developing procedures for expediting review and consideration of wetland delineations submitted by certified wetland delineators. Individuals passing both the written test and a field practicum administered by one of the demonstration districts will remain provisionally certified until a final WDCP is implemented na-

tionwide. The Corps intends to issue a proposed rule for the WDCP in the *Federal Register* in late spring or early summer of 1994, with an opportunity for public notice and comments. The Corps anticipates implementing the WDCP nationwide upon completion of the rulemaking process. When published, copies of the proposed rule will be available from the Norfolk District office, the EPA Wetlands Hotline (800) 832-7828, or the Regulatory Branch of the Office of the Chief of Engineers (202) 272-0199.

**VAWP QUESTIONNAIRE RESULTS**

The following are the results of the questionnaires which were distributed at the initial meeting of VAWP.

**What is your profession?**

Environmental (Wetland) Scientists came in first with 16 followed by (nine) Consultants, (four) Environmental (Wetland) Engineers, (three) Lawyers, (three) Surveyors, and one or two of the following professions: Academia, Planner, Environmental Tech., Forester, Business, Landscape, Architect, and Fish & Wildlife Biologist.

**Where is the most convenient location to meet and when?**

There was a tie between Richmond and Tidewater with VIMS coming in a strong third place. Most people wanted to meet on a weekend, preferably Saturday, with Friday as their next choice.

**Newsletter**

Everyone felt a newsletter would be beneficial to the membership, and most thought it should be published quarterly. Suggested topics were: regulation, research & abstracts, mitigation

& project design, training/certification, delineation, current events, policy, functions & values, workshops, current wetland issues, endangered species, new technology & technology transfer, hydrology, tech. book reviews, associated news, school partnerships, local/regional issues, interesting projects, soils, and restoration.

Twenty-two people said they would be willing to write an article for the newsletter, and 20 would be willing to contact others to write articles.

**Membership Directory**

Almost everyone wanted a membership directory and the majority wanted name, profession, address, telephone, and fax number included. About half of those surveyed wanted area of expertise included.

**Symposia or Workshops**

Forty people indicated an interest in this category. Most were interested in mitigation and design workshops or symposia. Other subjects suggested were: delineation, regulations, habitat and functional evaluation, policy, cur-

rent issues, functions and values, delineation of disturbed site, plant/soil identification, banking, identification of grasses, stormwater management and certification.

**Panel Topics**

Suggested topics for a panel included mitigation, delineation, BMPs, environmental education, legal, regulation, surveying, policy, functional analysis, development planning, ecology, wetland creation monitoring, costs of alternatives analysis, hydrology, and applicant's experience with regulatory process. Eight people are willing to serve on a panel and 35 people indicated they would ask others to participate.

**Design Competition**

Those surveyed were split on this question with 17 yes and 15 no. The two main categories suggested were mitigation and stream restoration. Two other categories were shoreline stabilization and beach nourishment. ❖

## RECENT AND UPCOMING CORPS POLICY DEVELOPMENTS

### Recent Developments

On January 6, 1994, the Corps, the Soil Conservation Service (the "SCS"), EPA, and the Department of the Interior entered into an agreement (which makes the SCS the lead agency for making wetland determinations on agricultural lands under both the Clean Water Act and the Food Security Act. "Agricultural lands" are defined as "those lands intensively used and managed for the production of food or fiber to the extent that the natural vegetation has been removed and cannot be used to determine whether the area meets applicable hydrophytic vegetation criteria in making wetland delineations."

The agreement requires the four agencies to develop a set of "mapping conventions" for SCS's use in making wetland delineations on agricultural lands. The deadline for implementing the agreement was May 6, 1994.

Additionally, in mid-May, to emphasize that all wetlands are not of equal value, EPA and the Corps issued guidance to its field staff highlighting the flexibility that exists to apply a less vigorous permit review for small projects with minor environmental impacts.

### Proposals Under Development

The Corps is currently conducting an internal review for several important regulatory proposals, including:

### Nationwide Permits

The Corps plans to publish several proposed rules for public comment later this summer affecting several existing nationwide permits and proposing several new NWP's.

NWP #26 (Headwaters and Isolated Discharges): The Corps will propose that the acreage limits in NWP #26 be lowered to either 1/4, 1/3, or 1/2 of an acre for fills without notice and 3, 5, or 10 acres for total NWP #26 fills. The Corps will propose one combination of

these limits, but will seek comment on all of the potential combinations.

NWP #18 (Minor Discharges): The Corps will propose raising the limits in NWP #18 from 25 cubic yards and 1/10 an acre of wetlands impacts to 50 cubic yards and either 1/8 or 1/4 an acre of wetlands impacts.

NWP #19 (Minor Dredging): The Corps will propose to increase the limit in NWP #19 from 25 cubic yards to 50 cubic yards.

The Corps will also propose to combine NWP's 18 and 19 into NWP 26. This will consolidate these related NWP's. However, it is unclear at this time if this will diminish the individual utility of any of the three NWP's.

Several "housekeeping" changes will be made to other existing NWP's to make clarifications and reflect recent administrative interpretations.

The Corps will also propose two new NWP's:

- ◆ A new NWP for mining activities;
- ◆ A new NWP for wetlands excluded from regulation by the SCS under the Food Security Act (i.e. Minimal effects determinations and the cropped wetlands exemption) subject to conditions and, possibly, acreage limitations.

### Other Policy Initiatives

The Corps will publish a regulation this summer proposing an administrative appeal process, for landowners to contest wetland delineations and permit denials. It is likely that appeals will go to a District level Corps appeals board.

In July or August, the Corps will publish a proposal to develop and implement a wetland delineator certification program.

Finally, this fall, the Corps will publish a proposal which would require the Corps to issue a decision, with minor exceptions, on most permit applications within 90 days after the application is complete. ❖

## VAWP COMMITTEES: WHAT'S HAPPENING?

The Membership Committee has been actively pursuing VAWP's goal of doubling its membership this year, meeting twice since the committee was initially formed. The initial membership drive targets existing organizations that have lists or directories of members that can be obtained as a target mailing list. Plans are also underway for a multiday wetland symposium to be held in conjunction with the annual business meeting in 1995. Various topics for the symposium, such as wetland classification, functional assessment techniques, mitigation, and wetlands research are surfacing. The Wetland Delineators Certification Committee will investigate development of a certification program in Virginia either through the Commonwealth, the VAWP, or other sources. The Wetland Delineation Education Panel will ultimately serve to implement a VAWP-sponsored certification

program, if such a program is developed. While plans for a wetland delineation certification program are developing, the education panel will establish training and education opportunities in wetland issues, including delineation.

The Program, Nomination, and Bylaws Committees will hold their first meetings in late summer. Members for the Bylaws Committee, which will draft proposed changes to the VAWP bylaws, have not been selected. If you are interested in participating, please contact the committee chairperson. The Ways and Means Committee is in the process of getting organized and is seeking sponsors, public and/or private, to underwrite in whole or in part the expenses of the workshop planned for July 15, 1994. for the Northeastern

An excellent guide for wetland professionals interested in selecting plant species for various wetlands situations. The guide is divided into four plant sections: Submerged and Floating Aquatic Vegetation, Herbaceous Emergent Vegetation, Shrubs, and Trees. Each section has the plants listed alphabetically by scientific name followed by some common names. Each species is sketched and is accompanied by a section on each of the following: Characteristics, Growth, Planting, Habitat, Wildlife Benefit, and Hydrology.

Of particular interest to wetland designers is the Hydrology Section that discusses the wetland regime for which the plant is most suited and the Planting Section that discusses what forms of the plant (seeds, rootstock, bulbs, etc.) are available for planting and suggested spacing for uniform cover.

The index contains both common and scientific names for easy reference. The plant sketches are somewhat lacking in detail; however, it must be noted that this guide is not intended as an identification manual and other sources are available for that function.

In summary, the guide is a good reference book for both the wetland scientist interested in designing created wetlands and also the novice who is simply interested in wetland plants.
